June 5, 2025

Mayor Witt called the meeting to order. Schmidt made a motion to approve the minutes from the previous meetings. Farley seconded the motion. All voted in favor. Motion carried.

Schmidt made a motion to approve the purchase orders through consent agenda. Farley seconded the motion. All voted in favor. Motion carried. Treasurer Report and Budget Reports were also reviewed. There was no Public Comments.

Carina Roybal reported that summer reading is underway with several sign ups already. The AC leak has been repaired, but water is still getting in when it rains. Maintenance is looking into a solution. Maintenance replaced the downstairs lights. Pre-K came on May 8th for a library tour. Carina visited Alva Public Library on May 12th. The Library has donated books to the Elementary Library.

Guerrero Garcia reported 8 clean up letters, 3 building permits for May and not much activity for the monthly K-9 report. Scott Hedrick reviewed the Animal Control report with Council, 1 PTS, 1 died and started with 5 dogs, but only have 1 dog left in the shelter as of 5/31/25.

Winter Roybal had 11,392,000 gallons well water pumped with 852 pounds of chlorine pumped into wells. Three water meters quit working, 1 was replaced. There was 1 water complaint, 3 street complaints, 1 alley complaint, and 2 gas odor call outs. Water well application was approved by DEQ. Earles Engineering will get bid information sent out. Schmidt would like to have someone look into getting some material for the alleys for repairs. 96.71 tons of trash has been dumped for a fee of \$3,384.85. Landfill revenue was \$759. One grave was opened. The pool heater is not working, a Raypak tech will be out on 6/10/25 to check it out.

Schmidt made a motion to approve to declare Golf Course equipment as surplus. Clement seconded the motion. All voted in favor. Motion carried.

Schmidt made a motion to approve to declare 2018 Police Ford Explorer as surplus. Clement seconded the motion. All voted in favor. Motion carried.

Hofferber made a motion to approve Anjanette Gibler's Treasurer Bond. Farley seconded the motion. All voted in favor. Motion carried.

Schmidt made a motion to approve to apply escrow balance to the 2025-26 Work Comp Premium. Clement seconded the motion. All voted in favor. Motion carried. There was no new business to be discussed.

In the Mayor's report, Witt talked about the valley gutter estimate from Austin Concrete for replacement, the Hooker Market had great reviews, and mentioned that there's a brewery showing interest in the Market.

Hofferber made a motion to adjourn the meeting. Clement seconded the motion. All voted in favor. Motion carried.
