Regular Meeting  
June 8, 2023

Mayor Aaron Witt called the meeting to order. Witt asked for approval or corrections to the minutes of the previous meetings on May 4, 2023 and May 25, 2023. Buschman made a motion to approve the minutes. Hofferber seconded the motion. All voted in favor. Motion carried.

Schmidt made a motion to approve the purchase orders by consent agenda. Farley seconded the motion. All voted in favor. Motion carried. Treasurer and Budget Reports were also reviewed.

Roybal informed the Council that Cline Construction will start June 12, 2023 on the utilities for Kirk Welding. Bennett Construction will schedule Fire Hydrant for replacement/updates. She is working with the County on alley repair between Davis Welding and Mills Ideal. Received cold mix and will start filling potholes soon. Well #7 and #8 will be running on the generator, per agreement with TCEC, from 3 PM to 8 PM every day. There are heater and pump issues going on at the City Pool. Daniel Cano-Torres has been weed spraying around parks.

Wayman said the Ambulance passed inspection. The Fire Department will have fireworks this year. Hedrick shared K-9 policies with the Council. Garcia brought Echo, the K-9, to Council meeting. Garcia also informed the Council that clean-up letters will be sent out soon and Steve Baird's trailer has been moved to landfill.

Farley voted to take no action on the Hooker Little League after visiting with Brown and Harrison about field upgrades for the little league baseball field that's owned by the City. Buschman seconded the motion. All voted in favor. Motion carried. Buschman voted to take no action on the Fire Department and Ambulance Department equipment purchases after talking to Wayman. Farley seconded. All voted in favor. Motion carried.

Buschman made a motion to approve declaring 2007 Elgin Street Sweeper as surplus. Schmidt seconded. All voted in favor. Motion carried. Farley made a motion to approve declaring the 2003 Chevrolet 1T pickup as surplus. Schmidt seconded. All voted in favor. Motion carried. Schmidt made a motion to approve declaring the 1995 Ford Truck as surplus. Buschman seconded. All voted in favor. Motion carried. The Treasurer Bond for Anjanette Gibler was approved with a motion from Schmidt and a second motion from Hofferber. All voted in favor. Motion carried.

Being as there was no further business to be brought before the council; Buschman made a motion to adjourn the meeting. Hofferber seconded the motion. All voted in favor. Motion carried.
